## Between

Rajgangpur Municipality, Rajgangpur ,Dist.Sundergarh,Odisha , Represented through Executive Officer,Rajgangpur Municipality,Rajgangpur here in after referred as the First Party.

## And

Sarbati Devi Women's College, Main Road, Rajgangpur Dist.Sundergarh,Odisha represented through Principal Sarbati Devi Women's College, Rajgangpur, Dist. SunJergarh, Odisha here in after referred as the Second Party.

Where as the first party engaged in collection, reception, storage, transportation, treatment, disposal and handling of any form of Bio-Degradable and Non-Bio Degradable Domestic / Solid waste / E-Waste in compliance with the Waste Management and handling rules and regulation of Central Government (Government of India), Ministry of Environmental and Forests. Possesses necessary Authorization from Orissa State Pollution Control Board to install and operate a common waste treatment and disposal facility as per norms and conditions laid out by Orissa State Pollution Control Board.

Whereas the Second Party is Educational Institution Establishment is in need of disposal and treatment of Bio-Degradable and Non-Bio Degradable / Solid / E-Waste generated from its premises situated at Main Road, Rajgangpur, Dist. Sundergarh, Odisha.

Whereas the Educational establishment namely Sarbati Devi Women'S College, Rajgangpur, desire to enter in to a long term understanding that Rajgangpur Municipality will operate the facility for the establishment to collect, transport and treat the Domestic waste/E-Waste generated for final disposal strictly in accordance with the authorization of the Orissa State Pollution Control Board on collection of mutually agreed charges.

Now this Memorandum of understanding witnesses as under :-

- 1. In consideration of the above recitals and in consideration of terms and Conditions set out herein and in consideration of the charges agreed to be paid to Rajgangpur Municipality as set out in the Memorandum of understanding for collection of Bio Degradable and Non-Bio Degradable Waste / Solid Waste / E-Waste, Educational Institute here by enter in to agreement with Rajgangpur Municipality for collection and disposal of waste from its premises.
- 2. This memorandum of understanding shall be valid for a term of 5 years, from the date of agreement. The parties may mutually extend the term for such further term as may be agreed. This agreement shall be ordinarily in force for the demised duration as set out in the agreement unless terminated earlier.
- 3. Sarbati Devi Women's College agrees to pay Rs.1200/-(Rupees one thousand two hundred) only per month the charges as the User fees to the Rajgangpur Municipality punctually and periodically for collection and disposal of waste. Which shall form the essence of contract and will be entered in to separately at revised price as mutually agreed by both parties. If payment obligations are not fulfilled punctually as per Terms of this understanding and shall be at liberty to discontinue its service and or to terminate the agreement on that count with due intimation and one month in advance to Sarbati Devi Women's College.
- 4. Sarbati Devi Women's College during this term of memorandum of understanding shalt not enter into any arrangement or agreement with any other party or organization for wastes treatment or disposal or handling. Any Price Escalation or User Fees hike by Rajgangpur Municipality shall be communicated in written to Sarbati Devi Women's College .

11. It is agreed to include/delete any clause/s that according to the concerned of Orissa state Pollution Control Board and Rajgangpur Municipality forms part of this Memorandum of Understanding on a later date with mutual consent by both parties (Rajgangpur Municipality and Sarbati Devi Women's College).

12. All disputes arising out of or incidental to or concerning this Agreement shall be in accordance with the Indian Arbitration and Conciliation Act only and shall be referred to the decision of the sole arbitrator to be nominated by the representative of Rajgangpur Municipality and Sarbati Devi Women's College and the decision of the said arbitrator shall be final and

binding on both parties.

13. Sarbati Devi Women's College hereby agrees to deliver the waste generated for disposal at the scrap yard for E-Waste or garbage pit of the College premises. at Main Road Rajgangpur -770017, On a Daily /Weekly / Fortnightly /Monthly basis to Rajgangpur Municipality. Sarbati Devi Women's College shall deliver waste weighed and authorize a representative for acknowledging collection of waste by Rajgangpur Municipality. Rajgangpur Municipality will not be responsible for any lapses in the event of waste not properly delivered for disposal at the agreed premises.
