1. Parties to the Agreement

5. Roles and Responsibilities of iDreamCareer

- Provide resource persons, trainers, and facilitators for sessions.
- Conduct psychometric assessments and share relevant guidance insights with students.
- Organize scholarship awareness drives and industry expert interactions.
- Support students with career-related information and opportunities.

Roles and Responsibilities of the College

- Provide access to students for participation in the program.
- Provide suitable classroom, seminar hall, or existing IT infrastructure for conducting activities.
- Coordinate with iDreamCareer for scheduling sessions and assessments.
- Ensure smooth implementation of the program without disruption to regular academic activities.
- Nominate a faculty coordinator for effective communication and coordination.

6. Use of Infrastructure

- iDreamCareer shall use the existing IT infrastructure and facilities available in the College.
- No additional equipment or infrastructure shall be provided by the College unless mutually agreed upon in writing.

7. Duration of the MoU

This MoU shall remain valid for a period of one (1) year from the date of signing and may be extended by mutual written consent of both parties.

8. Confidentiality

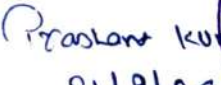
Both parties agree to maintain confidentiality of student data and information collected during assessments and program activities, and such data shall be used only for educational and career guidance purposes.
